Notes to the Financial Statements Year Ended February 29, 2024

1 Nature of Operations

The Wentworth Residents' Association is a homeowners' association comprised of homeowners in the Wentworth community of Calgary, Alberta. The Association is dedicated to ensuring the betterment of the Wentworth community through the management of neighborhood landscaping and common area maintenance.

2 Revenue Recognition

Residence fees and other income are recognized in the financial statements as revenue in the period that the events given rise to the revenue occurs, provided that reasonable estimates of the amounts can be made and collection is reasonably assured.

3 Land

This refers to the parcel of land known as 8901 9 Avenue SW. It is the natural wooded area adjacent to 9th Avenue SW between Wentworth Rise SW and 89 Street SW. The land was gift to the Association by the Developer and is the responsibility of the Association to maintain. The figure used to value this land comes from the City of Calgary's Annual Assessment Notice.

4 Administration Expenditures

These include, but are not limited to: banking fees, mailbox rental charges, postage, printing costs, meeting costs, land title request fees, web hosting and online payment processing fees.

5 Prepaid Insurance and Mailbox Rental

Insurance policy covers the period from December 1 - November 30. Mailbox rental period is 24 months and is only paid every other June.
